

The Post-Secondary Enrollment Options (PSEO) Program allows qualified high school students to earn college credits and, with the high school's permission, to use those credits toward the completion of your high school graduation requirements. Courses covered by the PSEO funding are offered during the fall and spring terms at the-Finishing Trades Institute of the Upper Midwest. The cost for all course tuition, fees and required textbooks are covered under the PSEO program.

ELIGIBILIT-Y CRITERIA FOR PSEO

Must be a Senior or Non graduating senior in high school and have an interest in "Hands On" or work-based learning.
